Bina Patel called the meeting to order at 3:37pm.

PUBLIC COMMENT: None

STAFF ANNOUNCEMENTS- Rob O'Keefe and Lindsey Stevens welcome Katie Soltas-Director of PR to the See Monterey Team. Bina Patel acknowledged Kimbley Craig and Teri Owens for their long-standing contributions and collaboration with See Monterey over the years. Rob provided a brief overview of recent awards and press coverage, an upcoming Wayfinding workshop, See Monterey's crisis communication protocols and monitoring of local and national tourism policy and impact.

SPECIAL PRESENATION

Lauri Eberhart with Friends of Laguna Seca introduced herself to the board and highlighted the organization's focus on restoration and revitalization of WeatherTech Raceway Laguna Seca. Lauri highlighted the \$50 million+ capital improvement plans focused on upgrades and development of the entire property. Upcoming projects, new building structures, increased community activities, events, recreation, and entertainment opportunities were discussed. Lauri also spoke to the track as being an economic engine that will benefit all of Monterey County.

B. Board Development & Leadership Symposium

Top takeaways included the positive evolution of See Monterey over the years, the boards assistance in helping to source funding, and the importance of collaboration that can benefit businesses, the community, and residents.

C. See Monterey FY2024-25 Business Plan Update

Committee chairs from the Marketing, Sales, Finance, and MCTID committees provided an update on the FY2024-25 Business Plan items that were reviewed and discussed at recent committee meetings. Highlights included revised success metrics, productivity, occupancy updates, and TID assessment increase updates.

D. FY2024-2025 Budget Reforecast

Rob and Richard Dole provided an overview of the FY2024-25 Budget Reforecast with topline overviews of variances by department. Areas where additional funds will be used was also reviewed including public relations efforts, paid media and in-market meeting planner events.

There was a motion to approve the FY2024-25 Budget Reforecast as presented and recommended by the Finance Committee. M/S Teri Owens / Kirk Gafill. The motion carried unanimously.

E. ARPA- County Recovery Investment Recap

Rob presented a brief summary report of See Monterey's 3-year ARPA program and deliverables highlighting the projects that would not have otherwise been possible without the funds. Additional programming allowed See Monterey to bolster, extend and add new elements to our destination marketing approach and compete more aggressively within our comp set.

BOARD MEMBER ANNOUNCEMENTS: Bina recommended using the Board Member Announcement time for board members to discuss items not included in the agenda but are important to See Monterey and the community. Bina kicked off a conversation regarding the recent AT&T Pro-Am, discussions ensued regarding occupancy and format of the event. Donna Langley noted over 3.3 million viewers tuned into 15+ hours of televised coverage of the event. Next year's Pro-Am dates of February 9-15th, 2026 were also announced.

GOOD OF THE ORDER: Paula Joy MacNab of the Monterey County Film Commission announced an upcoming Oscars party they will be hosting on March 2nd inviting the board to join.
