## REGULAR AGENDA

**New Business** 

A. See Monterey FY2024-25 Business Plan Update

The See Monterey team provided business development, marketing communications, finance and administration business plan progress YTD with committee chairs speaking to high level updates from their respective meetings. Lindsey presented How2Hwy1 aimed to provide a how to marketing program for visitors to navigate the road closure with unified messaging throughout the region. Lindsey also spoke to the James Beard partnership "A Culinary Road Trip Through Coastal California" media and consumer dinner happening in New York in May.

## B. FY2025-26 Budget Workshop

Rob O'Keefe opened the budget workshop by highlighting all of the stakeholder input and collaboration, situational analysis and forecast data that goes into creating next years budget. New opportunities such as event strategies, further economic development and transportation. Richard Dole presented the FY25-26 revenue and expense considerations noting slight ADR increases YOY in jurisdiction investment, similar occupancy rates YOY and a new TID rate that goes into effect July 1, 2025. FY25-26 budget reflects a 10% increase to \$13,819,770 up from

\$12,395,478 last year. Budget breakdowns by department were then discussed. Marketing noted a 20% increase in budget for expanded reach to further out markets and an international presence. Business Development noted a 9% increase in budget to show up bigger at events and for increased meeting incentives to bring new business to the area. Administration and Community Relations propose nominal increases to their budgets of 12% and 6% with the purchase of BoardEffect software being introduced as the main increase in the administration budget. Changes to the benefits and compensation plans at See Monterey were presented to the board for review until the Executive and Compensation committees review at their next meeting.
